Directors: John Piper, Suzanne Newman, Jeff Chorba. Residents: Doug Bernstein, David Moretti, Jennifer Puyenbroek, Sue Cunningham, Joe Maselli, Grant Houda

CONFIRMATION OF NOTICE: Notice of the meeting has been distributed in a timely manner and was posted in the customary locations.

<u>Approval of The Minutes</u>: Don Meek called for an approval of the minutes from the February 4, 2020 meeting. A motion was made by Len and seconded by Scott and the minutes were approved unanimously.

Reports by Officers:

<u>President's Report (Don Meek)</u>: Don reported that this has been a very interesting year because of the pandemic. Sales were up with 15 new residents. The board is conducting its meeting using Zoom. Frank made significant improvements to the web site with all forms now on-line.

<u>Treasurer's Report (Frank Schwartz):</u> Frank reported all homeowners paid their 2021 Annual Assessment. There is no outstanding debt and we ended up the year with a cash surplus of \$28,800. He stated we are in a good financial position.

<u>Secretary's Report: (Len Biernat):</u> Seven board members and 6 residents were in attendance. There were sufficient proxies (60) to constitute a quorum.

Committee Reports:

Nominating Committee: Scott reported that the committee recommended Scott Wilkins, Jeff Chorba, and Suzanne Newman for three-year terms.

<u>ARC/Compliance (Frank Schwartz):</u> Frank stated that there were 52 ARC requests last year. There were seven roofs in "legal status" that may lead to litigation. He was advised that we should not take any HOA action until the issue has been resolved with the homeowner's lawyer and insurance company.

Social (Scott Wilkens): Scott noted that the committee will probably not have any events for the rest of the year

SWCA (Scott Wilkins): Scott gave an overview of the January 20 2021 SWCA Board meeting. He reported that 25 properties changed owners in December and 115 for the year. New cameras, with audio, have been installed at each gate. SWCA and the city are discussing installing "speed humps" in the community. The reserve fund at the end of the year was \$1,486K, an increase of about \$100K. Club profit was about \$500K for the year. SWCA will receive 75% of any profit.

Old Business: None

<u>New Business:</u> Don asked for a motion to approve the nominating committee recommendations. Len made a motion to approve the nominations and elect Scott Wilkins, Suzanne Newman, and Jeff Chorba to the board. The motion was seconded by John and adopted unanimously.
